FY 2018, 1st Quarter Business Forecast Questions and Responses

Background

The Agency's Business Forecast is an informational resource on potential funding and partnership opportunities at USAID. It is an advanced look at grants, contracts, and cooperative agreements that USAID is in the process of developing and plans to issue in the coming year. Organizations interested in working with USAID can use this tool to plan for proposal or application submissions.

General Business Forecast Questions

1. Timing of Solicitations: There are a number of solicitations that are expected to be released in mid-December. Similar to previous years, can NUSAID issue a notice to Contracting and Agreement Officers to be mindful of the holiday schedule?

USAID Response: We realize this is a busy time of year. While we cannot mandate the prohibition of solicitation releases in case of emergency or other urgent requirements, we have sent a note to our staff encouraging them to take the holidays into account and to avoid scheduling solicitation closings during this time period, if possible.

2. Value for Money Approach: Would USAID consider issuing RFAs with a value for money approach or a combined cost share and leverage requirement rather than the "standard" cost share requirement? This approach would expand the impact of the US dollar and/or broaden the resource pool for activities, such as the forecasted Madagascar health opportunities (IMPACT and ACCESS) and the Ghana Amplify Family Planning and Sexual and Reproductive Health Activity (AMPLIFY-FP).

USAID Response: With respects to Amplify-FP, for USAID/West Africa - we consider cost share contribution appropriate for the AMPLIFY activity. The intent behind the cost share is sustainability and to encourage new investment in family planning in the West African focus countries. On the more general question related to value for money and cost-share and leverage, leverage was developed in the context of Public-Private Partnerships as defined in ADS 303.3.27. However, it would be helpful to us for you to further elaborate your thoughts along these lines related to value for money to discuss and engage further beyond this specific Business Forecast question.

3. **Identifying Task Order Mechanism:** When TO/DOs are forecasted, can USAID also announce which IDIQ or GSA vehicle is intended to be used?

USAID Response: We encourage staff to list the contemplated GSA Schedule or title of the IDIQ contract in the "Award Description" field when listing TOs/DOs. We will continue to message this to staff when providing guidance on the Business Forecast.

4. **Items Removed from Forecast:** What is the exact timeframe that USAID decides to archive its forecast entries? Is there any type of standard that missions and bureaus are following?

USAID Response: We encourage staff to retain opportunities on the forecast for one quarter after they are cancelled. We also ask staff to keep items on the Forecast while they are open for responses. We will continue to message this to staff when providing guidance on the Business Forecast.

5. Limited Competition Activities on the Forecast: We have noticed several opportunities appear on the Forecast as general opportunities that were then released under existing LWAs or IDIQs, and therefore not open to the competitive bidding process. Can USAID provide clear indications on the forecast whether opportunities will have limited competition or not?

USAID Response: We will continue to encourage planners to include as much information as early in the planning process as possible, and to update opportunities as information changes. In the event an opportunity will be satisfied under an existing LWA or IDIQ, we instruct planners to identify the specific LWA of IDIQ mechanism that will be used in the "Award Description" field.

6. **Origin Date**: Can USAID add the origination date for opportunities to the forecast to know for certain when they first appeared and if they are new opportunities not previously forecasted?

USAID Response: This is not a current functionality, but we will explore the possibility of adding a field to future Business Forecast updates. We will continue to encourage planners to use the "Forecast Status Change" field to identify "New Opportunity Not Previously Forecasted" for appropriate actions and to update the status as an action moves through the pre-award phase. Business Forecast users can also sort opportunities by "Updated Date" to see which entries have recently been modified.

7. **Watch Feature:** It has been requested that there be a "Watch" button added to the website to allow people to be notified when there are changes to a particular item. Does USAID/OAA have any updates in regards to if/when it will be possible to "Watch" items on the USAID Forecast website?

USAID Response: This is not a current functionality, but we will explore the possibility of adding this field to future Business Forecast updates.

Washington Business Forecast Questions

1. Africa: Previously USAID has stated it was "analyzing options for future programming and may be seeking innovative ideas for the period leading up to the 2018 elections and beyond" in Africa. Would USAID be able to provide updates on countries of interest in Africa?

USAID Response: USAID is continuing to explore if opportunities exist at the Mission level to support election activities in upcoming African parliamentary elections.

2. **BFS:** FTF Innovation Lab – several innovation lab opportunities were recently added to the Forecast – capacity building for agriculture innovations; fish; and grain legumes. Is USAID planning on multiple awards for each of them? Are there target geographic regions for each of these opportunities? For a single award what is the anticipated maximum award size?

USAID Response: USAID is planning on one award for each Innovation Lab. The geographic region for the Fish Innovation Lab is Asia and Africa and worldwide for all the other labs. The anticipated maximum award size is approximately \$35M for each lab.

3. BFS: FTFIL: Fish

a. What countries will be targeted for the opportunity?

USAID Response: The targeted regional countries are Asia and Africa.

- 4. **BFS:** FTFIL: Capacity Development for Agricultural Innovation Systems
 - a. What is the relationship between this and the EU-funded project of the same name (see cdais.net)?

USAID Response: The EU-funded project is piloting materials and approaches that support the global mechanism launched by the G20 to the facilitate capacity development in agricultural innovation, called the Tropical Agriculture Platform (TAP). Amonth these materials and approaches is the TAP Common Framework on Capacity Development for Agricultural Innovation Systems. USAID is a TAP partner. Through this new activity, USAID will apply the principles and good practices outlined in the TAP Common Framework to strengthen its agricultural research and other capacity development investments. However, there is no formal relationship between this activity and the EU-funded project.

5. **BFS:** FTFIL: Grain Legumes

a. Does USAID plan to release this opportunity as a Leader with Associates Award?

b. Can USAID provide more information on the expected scope of this opportunity, as well as the expected areas of inquiry?

USAID Response: Yes, this award is currently contemplated as a Leader with Associates Award. At present, this scope is currently being revised. More information will be provided when the Notice of Funding Opportunity is posted to grants.gov.

6. **BFS:** FTFIL for Food Safety

- a. Is a FTF Innovation Lab for Food Safety anticipated?
- b. What are the expected release and award dates for this opportunity? Will this information be added to the business forecast?

USAID Response: Yes, USAID is anticipating releasing a Notice of Funding Opportunity for this Lab in February 2018.

7. **BFS:** Food Systems IDIQ

- a. Can USAID provide any information as to the reason for the delay of the Agri-Food Systems IDIQ?
- b. Does USAID still intend to release the Food Systems IDIQ on December 18, 2017?
- c. Will USAID release an illustrative task order with the release of the Food Systems IDIQ?

USAID Response: The Food Systems IDIQ is being removed from the Business Forecast as it is going through significant redesign considerations to most effectively program in this area.

8. **BFS:** Seed Systems Support

- a. Will the Seed Systems Support Project through the Bureau of Food Security be full and open competition? Will USAID restrict eligibility for the Seed Systems Support opportunity to universities and colleges as defined under Title XII?
- b. Does USAID intend to issue an RFI or pre-solicitation prior to the bid?

USAID Response: The Seed Systems Support activity will be an Assistance activity that will be competed full and open. Currently, USAID does not plan to restrict eligibility to colleges and universities. USAID does not intend to issue a pre-solicitation for this.

9. **BFS:** Knowledge, Data, Learning, and Training (KDLT)

- a. Can USAID please provide an update on the total estimated cost of the project? The Forecast lists the range of \$0 \$149,999.
- b. Can USAID please provide an update on the award mechanism?
- c. Is a description available for the Knowledge, Data, Learning and Training (KDLT) opportunity through the Bureau of Food Security?

USAID Response: KDLT is still in the early stages of design and we do not have the information requested at this time. While the amount will certainly be more than \$0 to \$149,999, USAID has not finalized our cost estimate, and therefore cannot provide an update. The award instrument is likely to be acquisition, however USAID has not made a determination as to the award mechanism.

10. **BFS:** Advancing Women's Economic Empowerment Framework

- a. Do you have an updated solicitation release date?
- b. Does USAID still expect to release this as a small---business set aside and GSA Task/Delivery order, or has this strategy changed following the Sources Sought process?
- c. Has USAID completed the market research to determine if the Advancing Women's Empowerment Framework (AWEF) opportunity will still come out as a small business set-aside under GSA Professional Service Schedule SIN 874-1?

USAID Response: The anticipated solicitation release date remains April 9, 2018. If that changes, the Business Forecast will be updated to reflect that change. USAID anticipates releasing this activity as a small business set-aside, utilizing the GSA Professional Services Schedule (PSS), SIN 874-1

11. BFS: Knowledge-driven Agricultural Development (KDAD) Project

a. The Knowledge-driven Agricultural Development (KDAD) Project was recently listed on GovWin, but has not yet been posted on FBO or in the forecast. Will USAID please confirm whether they plan to re-bid this opportunity, and if so, when it will be added to the forecast?

USAID Response: The project entitled Knowledge, Data, Learning and Training (KDLT) will be the follow on to the KDAD project. USAID is still in the process of designing the activity and it will be posted to FBO once a solicitation has been prepared.

12. **BFS:** Farmer-to-Farmer (F2F)

- a. Can USAID please indicate whether they believe this procurement will be released in mid-December, or whether any delays are anticipated?
- b. The current F2F project has several awardees according to geographic regions. Will this next round continue with a similar geographic split?

USAID Response: It is USAID's goal to issue the solicitation in December. If there are delays, that timeline would be pushed to January at the latest. This next iteration will include multiple awards. The solicitation will provide information as to the eligible geographic regions.

13. **DCHA:** IT Solutions

a. Is the scope of the DCHA IT Solutions procurement focused on internal (HQ) DCHA operations, or is it focused on DCHA-funded activities?

b. Will it be issued as a small business set-aside?

USAID Response: The DCHA IT Solutions procurement will be focused on internal (HQ) DCHA operations. It will likely be issued as a small business set-aside, however that has yet to be determined.

14. DCHA: Rule of Law

a. Please clarify whether USAID anticipates an extension to the Rule of Law IDIQ. If yes, how many years would be added and would there be a ceiling increase?

USAID Response: USAID anticipates an extension of the IDIQ by one year with no additional ceiling.

15. DCHA: SWIFT V

a. SWIFT V has been delayed for several months. Does USAID anticipate releasing the SWIFT V IDIQ on December 1, 2017?

USAID Response: SWIFT 5 RFP was Posted at www.FBO.gov on November 30, 2017.

16. **DCHA:** Active Communities Effective States (ACES)

- a. Can USAID please confirm that it intends to proceed with procurement of this mechanism?
- b. If so, can USAID please confirm that this is still the anticipated solicitation release date?
- c. Does USAID anticipate that it will issue a pre-solicitation with a draft SOW in advance of a final solicitation?
- d. Will there be a task order released with the final ACES solicitation?
- e. Could USAID please confirm that there will not be an illustrative task order or case study with the release of the ACES IDIQ?

USAID Response: The ACES IDIQ is being removed from the business forecast as it is going through significant redesign considerations to most effectively program in this area.

17. DCHA: Analytical Services IV IDIQ

a. Could you provide an update on the anticipated award date for the Analytical Services IV IDIQ? The previous Forecast Q&A indicated November 13th as the award date, but the awards have not been announced yet.

USAID Response: Finalization of the evaluation of proposals received is still ongoing; currently anticipate an award by September 30, 2018.

18. **DCHA:** Would USAID please confirm when the Office of Food for Peace intends to release a draft RFA for non-emergency programs?

USAID Response: FFP plans to release the draft RFA and country specific information for Burkina Faso and Niger to the Food Aid Consultative Group and post the RFA on the FFP website by the end of November 2017.

19. **DCHA:** In order to build on potential lessons learned and current program experiences, would USAID please ensure that required Food for Peace reports are on Development Clearinghouse? Along that same vein, would USAID consider providing the final evaluations and other reports for current Food for Peace programs in Burkina Faso and Niger (not currently available on the DEC) to potential Offerors prior to the release of the draft RFA?

USAID Response: USAID will ensure that the required reports are on the Development Clearinghouse (DEC).

20. **DCHA:** Would USAID please clarify whether the Office of Food for Peace is considering any other countries other than Burkina Faso and Niger for the FY 2018 funding cycle?

USAID Response: Not at this time for FFP development food security activities

21. **DCHA:** Does USAID anticipate a single country Food for Peace solicitation for Burkina Faso? When can we expect the release?

USAID Response: FFP plans to release the draft RFA and country specific information for Burkina Faso and Niger to the Food Aid Consultative Group and post the RFA on the FFP website by the end of November 2017.

- 22. **DCHA**: Implementer-Led Design, Evidence, Analysis and Learning (IDEAL)
 - a. Does USAID expect to re-issue the Implementer-Led Design, Evidence, Analysis and Learning (IDEAL) RFA in the near future?
 - b. If so, can you provide information on expected release date, funding levels, etc.?

USAID Response: Yes, USAID expects to re-issue the IDEAL RFA in the future. The expected release date and funding levels are TBD.

- 23. **DCHA:** <u>Infectious Disease</u> (with Epidemic or Pandemic potential) Standby Capacity for Humanitarian Emergency APS
 - a. In September 2017 USAID posted a pre-solicitation notice for Infectious Disease (with Epidemic or Pandemic potential) Standby Capacity for Humanitarian Emergency APS (SOL-OFDA-17-00088). This opportunity is not listed in the forecast. Does USAID still intend to release the APS in the coming months?

USAID Response: Yes, USAID intend to release an APS in the coming months.

24. **DCHA:** Empowerment and Inclusion Support Services (EISM)

a. Can USAID please advise if the EISM RFA will be re-released, and if so what the anticipated release date is?

USAID Response: USAID intends to re-release the ESIM as an RFP. An anticipated release date has not yet been established.

25. DCHA: FEWS NET 7 IDIQ

- a. Could USAID please provide an update on the anticipated award dated for the FEWS NET 7 IDIQ and the issuance of planned Task Orders to continue Pillar 1 activities following the conclusion of the current contract?
- b. USAID recently requested that offerors for the Famine Early Warning Systems Network (FEWS NET; SOL-OAA- 16-000189) extend their validity of their proposals until 2018. Could USAID provide an update on the procurement? Further, could USAID indicate if the current FEWS NET has been extended, and if so, until when?

USAID Response: USAID is in the process of reviewing all proposals received for the FEWS NET 7 IDIQ. No additional information is available at this time.

26. E3: Energy II IDIQ

a. Can USAID provide an updated RFP estimated release date?

USAID Response: USAID anticipates the RFP will be released early December.

b. Is USAID considering extending the current Clean Energy IDIQ to afford Missions and Operating Units (OUs) the opportunity to use the IDIQ to procure energy services?

USAID Response: USAID does not intend to extend the current Clean Energy IDIQ.

27. E3: Data and Evidence for Education Programs (DEEP)

- a. Can USAID please provide an update on the award mechanism?
- b. Will this activity be set aside for small businesses?
- c. Has USAID determined whether the <u>Data and Evidence for Education Programs</u> (<u>DEEP</u>) will be a full and open competition or whether it will be limited to small businesses?

USAID Response: USAID is currently working on the design of the Data and Evidence for Education Programs (DEEP) and has no additional information available at this time.

28. E3: Communications, Education, and Learn (CEL)

- a. The E3 Communications, Education, and Learning (CEL) item in the forecast is currently listed as due for release 11/1/17. Can USAID advise on a new expected release date or update to the forecast item?
- b. Can USAID please also provide an indication of the Award/Action Type for this opportunity which is still listed as TBD on the Business Forecast?
- c. Will this be a small business set aside?
- d. Will USAID proactively address any ambiguity for CEL implementers and partners regarding potential conflict of interest for downstream implementation activities that benefit from CEL's inputs?

USAID Response: USAID anticipates the solicitation will be released by November 30th, 2017. USAID anticipates the award to be a task order under GSA Schedules. The solicitation will be a small business set aside. USAID intends to address any potential conflicts of interest as soon as they may be identified in the course of work.

29. E3: Learning, Evaluation, and Analysis Project (LEAP III)

a. Can USAID confirm what is the anticipated solicitation date for LEAP III? The date in the forecast is June 30, 2017.

USAID Response: USAID anticipates the solicitation will be released by December 8th, 2017.

30. E3: Sharing Environment and Energy Knowledge (SEEK)

a. The E3 Sharing Environment and Energy Knowledge (SEEK) item has been removed from the forecast. A pre-solicitation for this procurement was released on 8/25/2017, but a cancellation notice has not been posted. Can USAID advise as to the status of the SEEK procurement?

USAID Response: Sharing Environment and Energy Knowledge (SEEK) is on the forecast anew (it was removed in error). USAID anticipates the solicitation will be released by the end of January 2018.

31. **E3**: Replace IDIQ

a. What are USAID's current plans regarding a REPLACE IDIQ follow-on? The last update was there were no plans at the time, suggesting the decision may be revisited.

USAID Response: No additional information is available at this time.

32. **E3**: Public Financial Management II & Leadership for Public Financial Management (LPFM) RFTOP

a. Per the forecast, the Leadership for Public Financial Management (LPFM) RFTOP will be released in mid-January. However, the PFM II IDIQ will not be awarded until late January. Does USAID expect to release LPFM before the award of PFM II?

b. Can you please confirm the release dates?

USAID Response: The LPFM RFTOP will be released after award of the PFM II IDIQ. We are unable to confirm a specific release date at this time.

33. **E3:** WADI

a. Given the recent public release of the new U.S. Government Global Water Strategy, does USAID anticipate a follow-on or successor to the Water and Development IDIQ (WADI)?

USAID Response: USAID does not have any information at this time regarding a followon to the Water and Development IDIQ.

34. **GH:** Multi-Sectoral Nutrition Activity

a. Could USAID please provide an update on the timing of an anticipated award decision for the Multi-Sectoral Nutrition Activity?

USAID Response: We anticipate that the award will be finalized by April 2018.

35. **GH:** Control and Elimination Project for Neglected Tropical Diseases

- a. Is the anticipated solicitation release date still slated for January 22, 2018?
- b. Does USAID know yet the number of awards that will be granted for CEP-NTDs?
- c. Per the forecast, the CEP-NTDs opportunity is listed as 1 of 2. Does that mean that USAID will be issuing a second bid related to CEP-NTDs?
- d. Does USAID anticipate that implementing partners must be non-exclusive

USAID Response: USAID anticipates issuing a solicitation at the end of January and anticipates issuing 2 awards. Organizations may choose to apply for either one or both awards. Organizations that are being proposed as subs under prime awards may choose to apply for one or both awards. Organizations that are being proposed as subs are allowed to be included under more than one prime for the same award.

36. **GH:** Youth Power

a. Does USAID anticipate a follow-on mechanism for the YouthPower extension? If yes, can USAID share guidance on a potential release date for this solicitation?

USAID Response: As noted in the J&A document that increased the ceiling for the YouthPower: Implementation IDIQ -- should a new global positive youth development mechanism be awarded in Year 4 or 5 of the current IDIQ, all new task order contracts or similar type buy-ins will be directed to the new mechanism. No additional information is available at this time.

b. The ceiling for the Youth Power: Implementation IDIQ was recently increased to allow the potential for further Task Order Requests for Proposals into 2018 and

2019. The J&A document references total estimated costs for "intents to contract" and "task orders for critical activities". Can USAID provide further details regarding the specific countries these TOs will cover?

USAID Response: This information was based on USAID's best knowledge at the time of the ceiling increase. USAID missions will include task order details in their forecast plans, as applicable.

c. The J&A document that increased the ceiling for the YouthPower: Implementation IDIQ discusses that the increase in ceiling is specifically for task orders that may be issued in Year 4, with an alternative mechanism in place for activities starting in 2019 and 2020. Can USAID please add this alternative mechanism to the forecast so that bidders may prepare?

USAID Response: USAID is currently discussing design options for an alternative mechanism, and no additional information available at this time.

- 37. **GH:** PMI new and expansion countries (Cameroon, Cote d'Ivoire, Niger, Sierra Leone, and expansion in Burkina Faso)
 - a. Does PMI anticipate bilateral investments? If so, when should implementers look for such opportunities on the USAID Business Forecast?

USAID Response: USAID does not anticipate bilateral awards for PMI in the new/expansion countries at this time. Initial PMI investments for these countries will be programmed through Global Health Bureau awards that have malaria and appropriate geographic scope. Approved investment plans (country malaria operational plans) for all PMI countries can be found at www.pmi.gov.

- 38. GH: Infectious Disease Detection and Surveillance
 - a. Can USAID update the release date for the Infectious Disease Detection and Surveillance solicitation under OASIS?
 - b. How is IDDS intended to work with the projects in the Emerging Pandemic Threats 2 (EPT2) program?

USAID Response: The RFP for IDDS has been posted to OASIS IDIQ holders on 11/27/2017.

IDDS activities will be developed and coordinated closely with key stakeholders involved in strengthening infectious disease detection and surveillance. These stakeholders include USAID partners implementing Emerging Pandemic Threat 2 (EPT-2), TB, Antimicrobial Resistance (AMR), and Global Health Security Agenda (GHSA), and other disease programs. USAID project management and country staff will continue to provide information and support to IDDS to partner with the relevant projects and stakeholders. USAID's EPT-2 program purpose is to mitigate the impact of novel

zoonotic pathogens that have pandemic potential and pose a public health risk. The project has three main areas of emphasis: 1) wildlife surveillance, risk characterization, and risk mitigation; 2) preparedness and response; and 3) one health(OH) university network strengthening and workforce development. EPT-2's activities involved strengthen diagnostic and surveillance capacity and the work of IDDS will complement and not duplicate these activities. IDDS' geographic scope and disease focus is broader.

39. GH: Emerging Pandemic Threats Program

- a. Will USAID plan to re-compete the Emerging Pandemic Threats Program?
- b. If so, will it continue to be three awards as currently configured? What is the expected solicitation date?

USAID Response: USAID intends to continue to support activities to prevent, detect and respond to emerging infectious diseases and pandemics. There is no information to share at this early date. The number of awards has not yet been determined. Solicitations for any follow-on awards will be posted in time to begin implementation in September/October 2019.

40. **GH:** Project SOAR

a. Does USAID plan to re-compete Project SOAR? What is the expected solicitation date?

USAID Response: We do plan to have a follow-on for Project SOAR. Our current timeline is to make the award before Sept 30, 2019, the anticipated solicitation release date will be updated as we near the end of FY18.

41. **GH:** Integrated Health Systems IDIQ

- a. Will the RFP include both the IDIQ and Task Order One or will there be two separate RFPs released? If so, when is the anticipated release date for Task Order One?
- b. What role do you see small businesses playing in this opportunity?
- c. Will this be a multi-award IDIQ or a single-award?
- d. How many large business awards and how many small business awards does USAID anticipate for the IDIQ?
- e. Does USAID intend to hold a pre-solicitation conference or release a draft scope of work?

USAID Response: This program is still early in design stage and the activity has not been approved yet. A subset of awards will be reserved for small business. It is planned to be a multi-award IDIQ. We anticipate approximately 5-6 awards, a couple of them will be reserved for small business. Currently we do not intend to hold any presolicitation conference or release a draft scope of work.

42. GH: Demographics and Health Surveys-8 (DHS-8)

a. Currently listed anticipated solicitation release date is 11/20/2017 and award date is 8/30/2018. Can USAID share if there are any changes to this timeline?

USAID Response: The Business Forecast has been revised to reflect the new anticipated solicitation release date. Please continue to monitor the forecast and fbo.gov.

43. **The Lab:** Research Technical Assistance Center (RTAC)

a. Can USAID confirm that, as described in RFI-OAA-17-000114 from USAID/LAB, the Research Technical Assistance Center (RTAC) is still forecast to be released in 2017?

USAID Response: The anticipated release date for this solicitation is early December. Once the solicitation is released, the Business Forecast listing will be updated to reflect this information.

44. **The Lab:** Global Development Alliance

a. The current Global Development Alliance (GDA) Annual Program Statement (APS) closes in February 2018. The GDA is not listed in the forecast. Does USAID plan to issue a new GDA APS? Is there a reason why it is not currently listed in the Forecast?

USAID Response: At this time, the GDA APS has a current closing date of February 23, 2018. There are plans to extend it for another year through an extension to be issued sometime in December 2017 or January 2018. Please continue to monitor the Business Forecast for additional information.

Mission Business Forecast Questions

1. Afghanistan: Afghanistan Value Chain-Crops

a. Could USAID please indicate whether it plans to issue an RFI or pre-solicitation notice in advance of solicitation release of the USAID/Afghanistan Value Chain-Crops opportunity?

USAID Response: RFI was released on March 15, 2017. There will not be a presolicitation noticed released prior to release of the solicitation.

2. Afghanistan: Is it still USAID's intention to release the Afghanistan Value Chain Crops and Value Chain Livestock procurements simultaneously? This would make it difficult for many bidders to consider pursuing both opportunities.

a. Will Supporting the Electronic Information Systems in Ethiopia to Improve Health Outcomes (previously posted as RFI: AID-663-RFI-17-00001) be added to the Business Forecast? What is the anticipated value of this opportunity? What is the anticipated solicitation release date?

USAID Response: We have no further information to share at this time.

USAID Response: This is being competed openly as a commercial item.

29. Georgia: Economic Security Activity

- a. From the FY2017 Q4 Business Forecast Q&A, USAID stated that the anticipated timing of the RFP release for the Georgia Economic Security contract is Q1 or Q 2 of FY 2018; however, the business forecast still states a release date of 11/28/2017. Could USAID kindly provide an update on the anticipated timing of release?
- b. Could USAID kindly provide an award description for the Georgia Economic Security contract?
- c. Does USAID intend to release a pre-solicitation notice for the Georgia Economic Security contract?
- d. Does this activity intend to include agricultural value chains?
- e. Is this intended to be a follow-on project?

USAID Response: The release date of the RFP is revised to reflect the revised anticipated release date of Feb 28, 2018; we have updated the forecast accordingly. USAID is still in the process of designing the activity and it will be posted to FBO once a

solicitation has been finalized. The Mission has issued the Georgia Economic Security-Request for Information (RFI-114-17-000001) on Feb 22, 2017. The presolicitation notice will be issued in mid February 2018. The general description of the requirement is in the forecast and is provided in the RFI, issued on Feb 22, 2017 posted on www.fbo.gov. Value Chains could be one of the possible approaches, as mentioned in the RFI. This will be a new activity, a full and open competitive contract.

30. Ghana: Are any upcoming Feed the Future or agricultural procurements anticipated for Ghana in 2018?

USAID Response: USAID/Ghana is in the midst of developing its country development cooperation strategy for 2018. After solidified, the upcoming opportunities will be posted in the USAID Business Forecast.

31. Ghana: Energy Development Program (GEDP)

- a. Will the Ghana Energy Development Program (GEDP) be released as a full and open opportunity?
- b. Is this a follow-on activity?
- c. Can USAID indicate which mechanism they intend to procure the this through since the opportunity is listed as a Task Order?
- d. Will this be just one award or multiple awards?
- e. Who are the current holders of the IDIQ?

USAID Response: The acquisition strategy for the Energy Development Program is still being developed. Once defined, the USAID Business Forecast will be updated accordingly.

- a. Could USAID please confirm that the anticipated solicitation release date of 2/15/2018?
- b. Could USAID please provide additional information on the Guatemala Nutrition, MCH and Family Planning forecasted opportunity?
- c. What is the award description? Is this opportunity a continuation to an existing project? If so, could USAID indicate which project and who is the incumbent?
- d. For the Guatemala MCH, Nutrition and FP activity, we know the MOH has prioritized a package of nine essential nutrition-specific and nutrition-sensitive interventions that need to be implemented at scale to achieve the GoG goal of a 10 percentage point reduction in stunting by 2020. Does USAID intend for this activity to address stunting via all of these nine interventions? If not, what is the scope of this specific activity related to nutrition?
- e. Will this project have more of a focus at the facilities level? Or the community level?

USAID Response: The draft SOW has changed. We do not describe the changes as significant. The anticipated date to issue solicitation is: o/a mid January. USAID intends to carry out a full and open competition process for this Contract. The PFM TO held by DAI is considered the predecessor project to NIS. These projects will operate concurrently for an as yet undetermined period of time. The draft NIS SOW remains distinct from the TO in that it covers more areas and partners with more GOG institutions. This procurement falls within the range on the Forecast..

36. Guatemala: Reaching and Linking with Key Populations

- a. Is this a follow on project?
- b. Is this is a Regional project? If so, which countries will this include?

USAID Response: This is a new activity/project. Yes, this is a Regional activity/project. It includes the countries of Guatemala, El Salvador, Honduras, Nicaragua and Panama.

37. Guatemala: Sustainable Forest Management and Water Activity

- a. Through what mechanism will this activity be released?
- b. When does the Mission expect to release it?

USAID Response: The Mission is still working on the choice of instrument and does not yet have an answer to this question. The Mission expects to release the RFA/RFP by the third quarter of FY 2018.

38. Haiti: Is USAID planning agricultural procurement(s) during FY 18? If so, can you please estimate the timeframe for the project to be published in the forecast and estimated RFP release date?

USAID Response: USAID is planning to begin the design of a new agricultural project in late Spring 2018, an estimated date. Once the planning begins, it should appear on the Business Forecast. There is no anticipated RFP release date at this time.

39. Haiti: Improving Governance in Haiti (IGHI)

- a. In June 2017, a Request for Information came out for the Haiti IGHI project. This project has not been added to the Forecast yet. Does USAID still plan to release an RFP?
- b. What is anticipated solicitation release date?
- c. What is the anticipated mechanism?

USAID Response: Yes, it is going to be a full and open RFP. The anticipated solicitation release date is February 20, 2018. The anticipated mechanism is a Contract.

- b. This opportunity has moved, over the course of 2017, from cooperative agreement to TBD. What is the award/action type?
- c. We had suggested this as a small business project via email to the Mission and OSDBU; what was the outcome of this request?

USAID Response: The solicitation should be released before the end of calendar year 2017. A contract is considered for the type of A&A instrument. A final decision has not yet been made if this will be a small business activity.

41. Haiti: Youth Civic Engagement

- a. In September 2017, a \$10M \$24.99M Haiti Youth Civic Engagement opportunity was listed in the forecast for release on September 13, 2017, but this solicitation subsequently disappeared from future forecasts. USAID Response: USAID/Honduras still anticipates a release on or about 12/31/2017. USAID/Honduras acknowledges that 1/30/2018 is not feasible and will update the date in the forecast. This is a new activity, there is no incumbent.

43. Indonesia: ASEAN Economic Integration Support Activity

- a. The current release date for the ASEAN Economic Integration Support Activity is December 5. Can USAID verify the current release date?
- b. Will this project be issued as a TO under the PFM II IDIQ? If so, will it be issued as a small business reserve under that IDIQ?

USAID Response: USAID/Indonesia confirms that it anticipates releasing the solicitation for the activity preliminary titled "IGNITE: Inclusive Growth in ASEAN through Innovation, Trade and E-Commerce" in early January 2018. For additional information regarding this anticipated activity, please see the Request For Information released on November 17, 2017, under Reference No. AID-497-RFI-18-000002 at fbo.gov.

USAID Response: USAID/Indonesia anticipates the release of a Request for Applications (RFA) in mid December 2017.

47. Jordan: Does USAID/Jordan expect to be releasing RFPs or RFAs focused on technical assistance rather than construction in FY18? The question is related to procurement notices that periodically appear in the forecast and then disappear a few months later.

USAID Response: Yes, the Mission does. When we can more accurately predict the quarter during which the solicitations will be released, we will update the forecast with that information.

USAID Response: This activity has been added to the Business Forecast. The solicitation is anticipated to be released in Quarter 2 of FY18.

- **53. Kosovo:** Local Effective Governance (LEGO)
 - **a.** Given that the Kosovo Local Effective Governance (LEGO) project was already awarded, why is it appearing on the Business Forecast again with an anticipated award date of February 2018 and as a new opportunity?

USAID Response: LEGO is still in the procurement process. The information on the Business Forecast is correct with projected award date of February 2018.

- a. Could USAID/Kyrgyz Republic please advise whether the "Enterprise Competitiveness Project" is a follow-on to any certain project?
- b. Are there any agricultural components anticipated?
- c. Does USAID plan to issue a pre-solicitation or RFI for this opportunity?
- d. Is the anticipated release date listed in the forecast (1/15/2018) accurate in light of the recently announced extension to the BGI Project?

USAID Response: The USAID/Kyrgyz Republic Enterprise Competitiveness Project is not a follow-on to a specific USAID project, but will build on the achieved outcomes and learned lessons of previous projects. The Project is not focused on specific sectors and does not have a specific agriculture component. USAID previously issued an RFI on September 14, 2016 as SOL-176-16-000011 with the title Enterprise Development Project. The responses informed the design of the current version of the Enterprise Competitiveness Project. USAID will issue a pre-solicitation notice for the Enterprise Competitiveness Project in December 2017. Yes, the anticipated release date in the forecast is accurate. The Enterprise Development Project is not a follow-on to BGI.

56. Laos: Microenterprise

a. Can you please advise which type of agricultural value chains will be targeted in the "Laos Microenterprise" activity?

USAID Response: USAID/RDMA is currently at the early stage of designing the Lao Microenterprise activity and specific value chains have not been identified. USAID released a request for information (RFI) related to this solicitation on Nov. 7, 2017 seeking information to help inform the design of this activity. The Mission is considering responses received to the RFI and is continuing with the activity design.

57. Laos: Trade and Investment

- a. Could USAID please advise whether this will include an agricultural component?
- b. Will this procurement be tendered under the PFM II IDIQ? If so, will it be issued as a small business reserve under that IDIQ?

USAID Response: USAID/RDMA is in the design process of this activity and so the decision to include an agricultural component has yet to be determined. Final determination of the most appropriate implementing mechanism for the Trade and Investment activity has yet to be made.

58. Laos: Rule of Law

a. Could USAID clarify if this will be an openly competed solicitation or will be this routed through an existing IDIQ?

b. If it will be openly competed, what is the anticipated choice of instrument?

USAID Response: USAID/RDMA anticipates a full and open competition for the Rule of Law activity. Final determination of the most appropriate instrument type for the Rule of Law activity has yet to be made.

59. Lesotho: Does USAID/Lesotho have a HIV combination prevention project in its forecast? If so, what is the anticipated release date?

USAID Response: Yes, USAID/Lesotho will include a HIV combination prevention and orphans and vulnerable children (OVC) program in its forecast. The anticipated solicitation release date is o/a February 2018.

60. Liberia: Is the Mission planning a new youth-focused activity? If yes, what will be the technical focus of the activity?

USAID Response: Yes, USAID/Liberia is in the early design phase for a youth-focused activity. It will be cross-cutting, likely to include Education, Health, Economic Growth and Democracy & Governance. The technical areas may include post-secondary institutional capacity building (TVET) and employment generation - investment in value-added businesses.

- **61. Madagascar:** Accessible Continuum of Care and Essential Services Sustained (ACCESS) (Mikolo Follow-on)
 - a. Could USAID please provide an updated anticipated solicitation release date and award date?

USAID Response: A Notice of Funding Opportunity is anticipated to be released end-January, 2018. A resulting award is expected mid-June, 2018.

- **62. Madagascar:** Hay Tao
 - a. Can USAID please provide an update on the anticipated award date of the Madagascar Hay Tao opportunity? Proposals were due October 31, 2016 and applicants are awaiting notification of award.

USAID Response: An award is anticipated on or around February 2018.

- **63. Madagascar:** <u>Improving Market Partnerships and Access to Commodities Together</u> (IMPACT)
 - a. What is the anticipated solicitation release date?
 - b. What is the anticipated mechanism?

USAID Response: Approximately January 2018. It is anticipated that this will be a Cooperative Agreement

64. Malawi: National Technical Assistance Support

a. This activity was on the forecast last quarter, but it is now missing from the forecast. Can USAID confirm whether it is still expected to come out?

USAID Response: This activity has been removed from the forecast in its entirety.

65. Malawi: Disability Activity

- a. Does USAID/Malawi expect to compete this opportunity through a traditional RFA and full technical applications, or is there a chance a different multi-stage approach may be used?
- b. Can USAID/Malawi provide additional details about any specific disabilities (e.g., blindness, deafness, dyslexia, etc.) or general disability categories (e.g., intellectual disability, specific learning disability, emotional disturbance, orthopedic impairment, etc.) intended to receive focused attention as part of the Malawi Disability Activity?
- c. In a recent opportunity of similar size and scope for Nepal, USAID requested a Program Manager, instead of a COP, to lead the program. The requirements for the Program Manager were more conducive to local hiring. Does USAID/Malawi expect that to similarly consider this factor when designating Key Personnel for this opportunity, to encourage local leadership?
- d. Does USAID Malawi expect this opportunity to target children with specific types of disabilities, or all types, including hidden disabilities such as language processing impairments and dyslexia?
- e. Does USAID expect this opportunity will have an an exclusive focus on the early grades, or may it also include a focus on the pre-primary level?

<u>USAID Response:</u> This activity will be procured through an IDIQ mechanism. The activity will be primarily focus on the visually impaired/blind, the hearing impaired/deaf and learning difficulties (which includes all other forms of disabilities, i.e. intellectual, learning, emotional, and orthopedic and dyslexia). It will focus on young children and especially girls grades one to four who are failing to progress in their schooling because they have visual, hearing, learning, etc. disabilities. It will <u>not</u> include a focus on pre-primary level. Yes, USAID/Malawi expects to similarly consider this factor when designating Key Personnel for this opportunity, to encourage local leadership

66. Malawi: Higher Education

- a. Will the Mission please provide more information about the scope of the activity?
- b. Does the term "higher education" refer to secondary, vocational or tertiary/university level education?
- c. Can the Mission provide more information on the anticipated targeted beneficiaries?

- d. Does the Mission plan to release a pre-solicitation or request for information?
- e. Will the Mission please confirm the anticipated solicitation release date as 12/15/2017?
- f. Can USAID/Malawi please confirm if the focus of this higher education award will focus on tertiary-level institutions and transition from secondary to tertiary level?

USAID Response: The USAID/Malawi higher education activity will complement existing Mission programming and priorities by focusing on improving higher education access and transition rates of vulnerable adolescent girls and young women (AGYW). The intervention will increase the opportunities of AGYW to attend university or pursue open and distance learning certificate, diploma, and degree programs and focus on high-demand employment subjects and training programs for increased economic impact. Support for shorter term post-secondary training programs will focus on high growth sectors and take into account the needs of Malawian employers or opportunities for self-employment. This will inform ways to support internships and other on-the-job training partnerships, particularly with private companies and local business leaders. Activity results will achieve the goals of increasing equitable access to higher education especially for vulnerable populations, strengthening higher education systems, linking education training to labor market and private sector needs, and improving the employment and business skills of youth so that they are better able to contribute to the economic growth of the country.

Higher Education is referring to post-secondary education whether vocational or tertiary leading to award of a certificate, diploma, or degree.

The program will provide equal access for both boys and girls who quality or are eligible for higher education programs, however special attention will be given to adolescent girls and young women who progress from primary to secondary school by increasing the opportunity for transition into higher education.

Yes. It will focus on tertiary level institutions and the transition from secondary to tertiary level.

The solicitation release date is planned to be early 2018. The Mission plans to release a pre-solicitation notice.

67. Malawi: Scale up VMMC Services

- a. Is there an incumbent?
- b. Under which mechanism will the TO/DO be released?
- c. Will competition be limited in any way to small business or to local entities, for instance?
- d. The forecast states that this solicitation will be released as a Task Order, could USAID provide the mechanism that the mission will utilize for this procurement?

e. Could USAID confirm if the anticipated Scale-up VMMC Services in Malawi as an HIV Prevention Strategy in Select Southern Malawi Districts

<u>USAID Response:</u> The activity is currently at the design stage. It is anticipated to be released under the Technical Assistance Support Contract 4 Africa (TASC4AFRICA) IDIQ. Confirm that the anticipated Scale-up VMMC Services in Malawi as an HIV Prevention Strategy in Select Southern Malawi Districts

68. Mali: Does USAID anticipate procuring additional cereal and livestock value chain projects in Mali to follow-on to the existing projects?

USAID Response: USAID/Mali is currently working on its Global Food Security Strategy, which has not yet been approved.

69. Moldova: Power Generation Feasibility Study

- a. We note that this is only \$1-4M over three years and it's listed as a contract. We believe this could be a small business opportunity as there are several small businesses with energy and power past performance. Would the Mission consider making this a small business opportunity?
- b. Can USAID please provide more details on the anticipated statement of work (SOW) for the Moldova Power Generation Feasibility Study?

USAID Response: The purpose of the Feasibility Study is to review the feasibility of investment in local heat and power generation to improve the energy supply security and thus ensure conditions for economic development of Moldova. The mission has determined this action will be fully competitive due to the complexity of this highly specialized activity, including the need to have expertise in multiple highly technical areas specifically related to power generation. Small businesses are highly encouraged to submit proposals.

70. Morocco: PAD Evaluation

a. Due to size (under \$1 mil) and scope of the USAID Morocco PAD Evaluation opportunity, will this be solicited as Small Business Set Aside (SBSA) or under IDIQ as an SBSA?

USAID Response: USAID/Morocco is planning on releasing the solicitation under a full and open competition solicitation method. Before that happens, USAID/Morocco has issued a Request for Information (RFI) to solicit feedback from stakeholders on the statement of work and will adjust our solicitation accordingly.

71. Mozambique: Currently, there is only one opportunity on the forecast for Mozambique. Can USAID indicate if there are plans to add funding opportunities for Mozambique in 2018?

USAID Response: At this time USAID/Mozambique only plans to issue the ECHO. The A&A plan has been updated.

72. Mozambique: Efficiencies for Clinical HIV Outcomes Activity (ECHO)

- a. The latest forecast indicates the anticipated solicitation release date for the Mozambique Efficiencies for Clinical HIV Outcomes Activity (ECHO) is January 15, 2018 although the anticipated award date is not until January 28, 2019. Can USAID please confirm the anticipated solicitation release date is accurate?
- b. Could USAID indicate if it will release an updated RFI or other pre-solicitation material before releasing the RFP?

USAID Response: The anticipated solicitation release date is January 15, 2018. USAID will issue pre-solicitation material before releasing the RFP.

73. Namibia: DREAMS Initiative

- a. An RFI was released for the Namibia DREAMS Initiative, but it has not yet been included in the Business Forecast live feed. Could USAID please provide further information on the anticipated release date?
- b. Will the opportunity be limited to local organizations?

USAID Response: The anticipated release date is December/January. This opportunity will be limited to local organizations.

74. Nepal: Local Governance Project/Support to Federalization

- a. For the Nepal Local Governance Project/Support to Federalization opportunity, does USAID anticipate issuing a pre-solicitation or a Request for Information (RFI) prior to the release of the RFP?
- b. Recognizing USAID's commitment to 20 core districts in the middle hills and Terai portions of Nepal's Far-Western, Mid-Western, and Western Development Regions, can the Mission please specify whether it anticipates broad assistance across all of the targeted regions, or more focused assistance to a smaller number of municipalities? If the latter, is the Mission able to provide guidance as to the targeted regions?
- c. Please confirm the forecasted release date for the Local Governance Project/Support to Federalization solicitation (1/18/2018) is accurate.

USAID Response: USAID/Nepal anticipates issuing a Request for Information (RFI) prior to the release of the RFP. USAID/Nepal anticipates a February 09, 2018 solicitation release date. USAID/Nepal will likely focus on working in approximately 20 to 30 target municipalities in the Mission's zone of influence, but have space to work at the provincial and national levels at the policy level.

75. Nepal: Social Services for AIDS-affected Orphans, Vulnerable Children and Adolescents

a. Can USAID please confirm if they intend to issue one or multiple awards?

b. Can USAID please share the geographic areas of the intervention?

USAID Response: This not a planned activity for Nepal.

76. Nepal: Per <u>USAID FY17 Qtr 4 Business Forecast Q&As</u> #99, USAID indicated that a "new inclusive education activity is under design" for USAID/Nepal. Can you please provide any additional updates regarding this opportunity and indicate the anticipated timeframe?

USAID Response: USAID/Nepal issued the Reading for All: Disability Inclusive Education for Nepali Children Notice of Funding Opportunity (NOFO) No. RFA-367-17-000009 to Grants.gov on September 26, 2017. However, October 25, 2017 was the concept paper submission deadline. The Mission has updated its A&A plan with additional information accordingly.

77. Nicaragua: Ideas Locales

- a. Can you please confirm the release date of 12/15/17 and anticipated award date of 9/28/18?
- b. The USAID Business Forecast page says this will be evaluated for impact.

 Assuming this evaluation will inform program design, when will this evaluation take place and what will be the process of securing a copy of this evaluation?
- c. Can USAID share additional information on the differences between this forecasted opportunity and the USAID/Nicaragua Lifting Nicaraguan Voices opportunity from earlier this year?

USAID Response: At present, we project the RFP to be released by 12/15/17, and the award to be made by 8/22/18.

The Impact Evaluation team for Ideas Locales will not conduct a typical evaluation, which often focuses solely on informing programming. Instead, the IE team is working together with program designers to co-create an evaluation that can respond to highlevel research questions. The IE will take place in conjunction with the activity from the date of award through the base period, and possibly the option period should USAID choose to exercise it. The implementing partner will receive a copy of the base period evaluation as soon as it is complete, ideally within 6-8 months of the completion of the endline data collection of the base period. Should USAID exercise the option period and determine it wants to continue the IE, the implementing partner will receive a copy the option period evaluation as soon as it is complete, ideally within 6-8 months of the completion of the endline data collection of the base period.

Lifting Nicaraguan Voices supports Civil Society Organizations, whereas Ideas Locales supports communities to organize, identify issues facing their communities, and advocate at the municipal level for the government to address those issues.

78. Niger: DFSA FY18

a. Can USAID please share any information available about the estimated timeline for the draft or final RFA expected release date?

USAID Response: The RFA was released November 27, 2017. Comments are due January 11, 2018.

79. Nigeria: Timing of Solicitations

- a. The forecast currently lists 5 opportunities for Nigeria to be released in the December 11-18 timeframe. Could USAID please clarify which of these are the priority for release?
- b. Given the forecast lists 5 opportunities for Nigeria to be released in December, how does USAID plan to accommodate the December holiday period when most offices in Nigeria are closed, including government which is a key design stakeholder?

USAID Response: USAID/Nigeria has updated the Forecast to accommodate for the December holiday period.

80. Nigeria: Rural Resilience

- a. Does USAID anticipate releasing a draft scope of work or pre-solicitation Request for Information?
- b. As per the information in the Business Forecast Q&A for quarter four of fiscal year 2017, can you please confirm that the approximate budget for this solicitation is \$30 million?
- c. Could you please confirm the geographic targeting within Nigeria for this solicitation and if Adamawa, Borno, Gombe and Yobe remain the target states?
- d. Will there be a pre-solicitation or bidders conference for this RFA?
- e. Can USAID please confirm whether the forecasted date of 12/11/2017 for Rural Resilience is accurate? If so, would USAID consider releasing the RFA on or after January 3 to accommodate the schedule of Nigerian Government employees and local stakeholders who may want to engage in program design but will not be able to do so during the December holidays?

USAID Response: USAID does not anticipate releasing a draft program description or pre-solicitation RFI or bidders conference. The range as listed in the Forecast is \$25M-\$49.99M. Adamawa, Borno, Gombe and Yobe remain the target states. The Forecast has been updated to accommodate for the holiday season.

81. Nigeria: Agricultural Competitiveness and West Africa Trade Hub Project

- a. Can USAID please clarify its intentions regarding the procurement of the Agricultural Competitiveness and West Africa Trade Hub project? Can USAID clarify if it intends for this to be procured as one large project?

- c. Can USAID add additional language describing the West Africa Trade Hub project's objectives, geographical reach, and proposed outcomes?
- d. Is USAID still anticipating a mid-December release for the Nigeria AgCompete & West Africa Trade Hub?
- e. What is the anticipated value for this activity?
- f. Will USAID consider doing an RFI for this activity?
- g. Would USAID please confirm that the anticipated release date is 12/11/2017?
- h. Does USAID continue to anticipate combining the West Africa Trade Hub Activity with the Nigeria Agriculture Competitiveness Activity?
- i. Would USAID please provide the target countries in addition to Nigeria for the West Africa Trade Hub?
- j. How does this announcement relate to the ongoing USAID NEXTT project and is this now viewed as containing follow-on elements or as a follow-on project?

USAID Response: Ag Compete and the West Africa Trade Hub Activity have been redesigned into one activity as stated in the Forecast. The Trade Hub activity will increase smallholder productivity and profitability and expand trade with a particular focus on job creation, increased exports and expanded access to finance to support value-added processing in West Africa. The target countries are Nigeria and other countries in the region. Further details will be provided in the RFP.

The forecast has been updated to reflect new release dates. The range as listed in the Forecast is \$50M-\$99.99M. An RFI is not anticipated at this time. Finally, this activity contains follow on elements, but is not a follow on project.

82. Nigeria: Addressing Education in Northeast Nigeria

a. Can USAID please advise on when the anticipated release date for this activity is?

USAID Response: The anticipated release date is FY 2018, Q3.

83. Nigeria: Agribusiness Investment Project

- a. Does USAID still anticipate releasing an RFP for the Agri-Business Investment Project in Nigeria?
- b. Would USAID please confirm that the anticipated release date is 12/15/2017?
- c. Does USAID intend to release an RFI for the Agri-Business Investment Project in Nigeria?

USAID Response: Yes, USAID Nigeria plans on releasing this RFP. The Forecast has been updated to reflect new release dates. An RFI is not anticipated at this time.

84. Nigeria: Social Services for AIDS-affected Orphans, Vulnerable Children, and Adolescents

a. Will the geographic focus be on Akwa Ibom, Cross River, Lagos, and Rivers?

- b. How many awards are anticipated to be issued?
- c. What are the anticipated target states for this RFA?
- d. Will there be a bidders' conference for this award?
- e. Could USAID please provide further information for the "social services" required under this project?
- f. Can USAID please confirm whether the forecasted date of 12/18/2017 for the Social Services for AIDS-affected Orphans, Vulnerable Children, and Adolescents RFA is still accurate? If so, would USAID consider releasing the RFA on or after January 3 to accommodate the schedule of Nigerian Government employees and local stakeholders who may want to engage in program design but will not be able to do so during the December holidays?

USAID Response: The geographic focus will be on Akwa Ibom, Cross River, Lagos, and Rivers. USAID anticipates up to two awards. A bidders conference is anticipated. Awards will include a range of services for orphans and vulnerable children. Further details will be available in the solicitation. The Forecast has been updated to reflect new release dates.

85. Pakistan: Could USAID/Pakistan confirm whether any additional agricultural funding will become available in FY 2018?

USAID Response: USAID/Pakistan can not confirm receipt of any additional agricultural funding in FY 2018.

86. Pakistan: Let Girls Learn

a. What is the new expected award date of this opportunity?

USAID Response: The LGL Cooperative Agreement (CA) was awarded on November 3, 2017

- **87. Pakistan:** Ambassador's Grant Fund Program (AFGP)
 - a. Has this program has been cancelled, or can we expect another funding round?

USAID Response: The Contract is already awarded. The award notice was published on FBO on 9/20/2017.

- 88. Pakistan: Sindh Enabling Environment Activity (SEEA)
 - a. The "Sindh Enabling Environment Activity (SEEA) was updated nearly two months ago to say that the activity had been cancelled, yet it still remains on the business forecast. Could USAID/Pakistan please provide an update on this opportunity?

USAID Response: Please see the updated Business Forecast for the latest information on SEEA.

89. Peru: USAID has multiple listings for opportunities in the environment sector in Peru and for South America Regional. These include: Promotion of Best Environmental and Social Management Practices with an anticipated release date of 11/15/2017; Securing a Sustainable, Legal, Profitable and Inclusive Forest Sector also with an anticipated release date of 11/15/2017; the Amazon Knowledge and Learning Platform with an anticipated release date of 1/15/2018; and, Representation of Indigenous Peoples in Governance of Amazon Forests and Waters with an anticipated release date of 2/15/2018. Does USAID intend to release the first two procurements simultaneously? Are there any changes to the anticipated dates of release for any of these four of these opportunities?

USAID Response: The first two activities mentioned (Promotion of Best Environmental and Social Management Practices and Securing a Sustainable, Legal, Profitable and Inclusive Forest Sector) are not specifically linked, but both are anticipated to be released soon. All anticipated solicitation release dates have been updated in the Business Forecast

- 90. Peru: Amazon Knowledge & Learning Platform
 - a. Does USAID intend to issue a pre-solicitation or draft SOW prior to issuance of the RFP?

USAID Response: Yes, USAID/Peru intends to issue a pre-solicitation notice in Fed Biz Ops.

- 91. Peru: Promotion of Best Environmental and Social Management Practices
 - a. Given that the anticipated RFP release date for the Peru Promotion of Best Environmental and Social Management Practices activity would likely require Offerors to develop proposals during a holiday season when many in the LAC region go on leave, would USAID consider postponing the release of the RFP until after the holidays, thereby allowing Offerors the opportunity to obtain meaningful feedback from stakeholders in the target countries to produce stronger proposals for USAID's review and consideration?

USAID Response: Thank you for your request. We realize this is a busy time of year and will take this into consideration when response dates are established.

92. Philippines: Does USAID/Philippines have a maternal, newborn, and child health project in its forecast? If so, what is the anticipated release date?

USAID Response: The Mission will provide the necessary information in regards to any maternal, newborn and child health work once the FY 2018 budget becomes clearer.

93. Philippines: Will USAID/Philippines have an energy opportunity in the forecast for 2018 or 2019?

USAID Response: The Mission will provide the necessary information in regards to any energy sector work once the FY 2018 budget becomes clearer.

94. Philippines: Currently, there is no entry on USAID forecast for the Philippines for any follow —on to the current regional health projects or new procurements for the USAID/Philippines Health Project 2017-2021. There was a an concept note released in January 2017, soliciting comments, but there is nothing on the forecast of when it will be potentially released. Therefore, can USAID/Philippines let us know when they envision any new forecast entry for USAID Philippines especially a follow on to the regional health projects?

USAID Response: We have released two RFAs related to TB activities. The Mission will provide the necessary information in regards to any family planning and maternal, newborn and child health work once the FY 2018 budget becomes clearer.

95. Philippines: Education

a. Can USAID provide more information on the expected focus of the multiple awards? Specifically does USAID expect that the next awards will maintain separate activities for early grade reading and youth work, similar to the current Basa Pilipinas and MYDev activities?

USAID Response: USAID/Philippines anticipates separate awards for early-grade reading and youth.

96. Philippines: Water Activity

- a. Could USAID please provide more information regarding this potential opportunity including a general description of the anticipated Statement of Work and information regarding the anticipated Award/Action Type for this procurement?
- b. Could USAID please indicate if it will release a draft RFP or other presolicitation material for the anticipated Water Activity?

USAID Response: The Mission will provide the necessary information in regards to water activity once the FY 2018 budget becomes clearer. It is to be determined if there will be any presolicitation engagements.

97. Philippines: B-Leaders

a. Does USAID/Philippines expect to have a follow-on energy activity after the conclusion of B-LEADERS?

USAID Response: The Mission will provide the necessary information in regards to post B-LEADERS energy sector work plans once the FY 2018 budget becomes clearer.

98. Philippines: Marawi

a. It's our understanding that additional funding for Marawi will be coming from USAID in a competitive process in 2018 but we do not see this on the forecast. Can USAID clarify if there will be an opportunity forthcoming and provide any information about it (timeline, award mechanism, etc.)?

USAID Response: To be determined.

- b. Will this activity include human resources for health or other aspects of health systems strengthening?

USAID Response: The Mission will provide the necessary information once the FY 2018 budget becomes clearer.

100. RDMA: Lao Basic Education

a. Is USAID able to provide any additional information on the nature of the Lao Basic Education program at this time?

USAID Response: USAID/RDMA is currently in the early stages of designing the Lao Basic Education activity. The anticipated solicitation release date per the business forecast is April 2018. Please monitor the Agency's Business Forecast for when more information becomes available.

101. RDMA: New Thailand Activity

- a. Could USAID please provide more information as to the scope for the "New Thailand Activity"?
- b. Can you provide the anticipated mechanism?

USAID Response: The scope of the New Thailand Activity will be focused on Conflict Resolution in Thailand. This activity is still in the concept design stage, so no decision has been made yet as to the anticipated mechanism.

USAID Response: Nothing is planned.

USAID Response: The procurement is on hold pending FY 2018 budget information.

USAID Response: The anticipated solicitation date for the Health Service Delivery Activity remains February 28, 2018.

USAID Response: USAID/Senegal expects no opportunities for release in FY18.

106. Senegal: Are any upcoming agricultural procurements anticipated for Senegal in 2018?

USAID Response: Yes, the following procurements are listed on this Business Forecast: Fisheries, Biodiversity, and livelihood & Agricultural Value Chain Services.

- **Senegal:** Equitable Access to Education in Southern Senegal
 - a. Can USAID please advise on when the anticipated release date for this activity is?

USAID Response: USAID/Senegal anticipates to release this activity by end of December.

- **108. Senegal:** Agriculture Value Chain Services
 - a. Does USAID anticipate releasing an RFI for the Agriculture Value Chain Services Activity in Senegal?
 - b. Will USAID please consider providing more details on the anticipated scope of work for the upcoming RFP?

USAID Response: USAID/Senegal does not plan to issue an RFI for this activity. USAID Response: This activity is envisioned as a buy-in to a centrally funded mechanism.

USAID Response: USAID/Central Asia plans to publish this RFP in mid-December, though the exact timing is not final. USAID/Central Asia will post a pre-solicitation notice shortly with additional information. The Tajikistan Agribusiness Competitiveness Activity is not a follow-on to a specific USAID project.

USAID Response: USAID plans to issue a Notice of Funding Opportunity (NOFO) to solicit applications for this activity. The A&A Business Forecast will be updated to include this information. Yes, eligibility will be worldwide with some exceptions. USAID does not plan to issue an RFI or hold a pre-solicitation conference at this time. The place of performance will be Tunisia. The anticipated NOFO issuance date is late February/early March 2018. Additional information will be provided with the NOFO.

USAID Response: The forecast has been updated to show a release date of December 7, 2017.

- **129. Ukraine:** ODG: New Media Activity
 - a. Can USAID confirm that this will be openly competed, and also clarify the procurement type for this solicitation?

USAID Response: The activity is still under design and the procurement type has not yet been determined.

130. Ukraine: Analytical Services IDIQ

a. The current solicitation release date for the Ukraine Analytical Services IDIQ is October 31, 2017, which has passed. Can USAID please provide an update on the status and anticipated timing for this opportunity?

USAID Response: The forecast has been updated to show a release date of December 7, 2017.

131. Ukraine: ODG: Donbas Activity

- a. Can USAID please confirm the intended geographic scope of this program, specifically which oblasts (provinces) USAID seeks to include in the program?
- b. Does USAID intend for applicants to work in occupied areas of Ukraine?

USAID Response: Since this activity is still in the design stage, the award/action type and the geographic scope, including specific areas the program will focus on, have not yet been determined. 132. Vietnam: Responsible Trade and Growth (SMEs Linkages)
