December 12, 2018 -- Launch of USAID's [Acquisition & Assistance Strategy](#), which calls for the New Partnerships Initiative

May 6, 2019 -- USAID Administrator announces NPI with the release of the [Conflict Prevention and Recovery Prevention](#) (CPRP) Annual Program Statement (APS) and the [Iraq Addendum](#)

May 15, 2019 -- Release of the [Bangladesh Addendum under the CPRP APS](#)

June 10, 2019 -- Release of the [Indonesia Addendum under the CPRP APS](#)

June 27, 2019 -- Release of the [Global Partnerships Advance Conflict Transformation \(GPACT\) Addendum under the CPRP APS](#)
